

## Your re-credentialing appeal rights

State	State specific appeal rights
AL	If you believe this proposed termination is in error, you have the right to submit a written appeal and an opportunity to request a hearing to refute the basis for Delta Dental's action, including the right to be represented by an attorney or another person of your choice during the appeal process.
CA	If you believe this proposed termination is in error, you may submit an appeal. The enclosed Membership Action Policies and Procedures set forth the procedures to request Delta Dental (a) review this proposed termination and (b) consider any written evidence refuting the basis for termination. Under Section 5 of the Membership Action Policies and Procedures, if no written evidence is received from you within 30 days of the Membership Action, then this Membership Action will take effect and there will be no further right to administrative review or appeal.
DC	If you believe this proposed termination is in error, you have the right to submit a written appeal and an opportunity to request—a hearing before the Board of Directors per Article 9, Section 9.1 of the Delta Dental of the District of Columbia Bylaws including the right to be represented by an attorney or another person of your choice during the appeal process.
DE	If you believe this proposed termination is in error, you have the right to submit a written appeal and an opportunity to request a hearing before the Board of Directors per Article XI, Section 2 of the Delta Dental of the Delaware Bylaws including the right to be represented by an attorney or another person of your choice during the appeal process.
FL	If you believe this proposed termination is in error, you have the right to submit a written appeal and an opportunity to request a hearing to refute the basis for Delta Dental's action, including the right to be represented by an attorney or another person of your choice during the appeal process.
GA	If you believe this proposed termination is in error, you have the right to submit a written appeal and an opportunity to request a hearing to refute the basis for Delta Dental's action, including the right to be represented by an attorney or another person of your choice during the appeal process.

TX	If you believe this proposed termination is in error, you have the right to submit a written appeal and an opportunity to request a hearing to refute the basis for Delta Dental's action, including the right to be represented by an attorney or another person of your choice during the appeal process.
UT	If you believe this proposed termination is in error, you have the right to submit a written appeal and an opportunity to request a hearing to refute the basis for Delta Dental's action, including the right to be represented by an attorney or another person of your choice during the appeal process.
WV	If you believe this proposed termination is in error, you have the right to submit a written appeal and an opportunity to request a hearing before the Board of Directors per Article 8, Paragraph 2 of the Delta Dental of West Virginia Bylaws including the right to be represented by an attorney or another person of your choice during the appeal process.
